<u>PUBLIC HEARING</u> – CONDITIONAL USE PERMIT U20-006 AMENDMENT #1 - Request for a conditional use permit (5 years) to allow the use of an off-premises sign in a C2 (General Commercial) zoning district on a parcel of land located at 2630 Desert Trail Drive and described as Tract C of Laughlin Ranch Unit 2, Tract 5127, Section 8, T20N, R21W, Bullhead City, AZ.

<u>PUBLIC HEARING</u> - CONDITIONAL USE PERMIT U25-002 — Request for a conditional use permit (15 years) to allow a temporary sand and gravel mining operation in an M1 (Industrial, General Limited) zoning district on a 78.49-acre parcel of land that is located at 1805 Bullhead Parkway and described as the N ½ of the SE ¼ of Section 18, T20N, R21W, Bullhead City, AZ.

<u>PUBLIC HEARING</u> - PRELIMINARY PLAT S25-009 - Request for approval of the preliminary plat for a project known as Dunton Estates, located at 135 Landon Drive, and described as Parcel B of the Parcel Plat recorded in Book 39, Page 67, Section 16, T21N, R21W, Bullhead City, AZ.

PUBLIC HEARING – ZONING MAP CHANGE Z25-003 / SUBDIVISION S25-008 – Request for approval of a zoning map change from R2MF (Residential: Multiple-Family) to PAD (Planned Area Development) with underlying R1L (Residential: Single-Family Limited) uses, and approval of the preliminary plat for a project known as Sun River Mesa Townhomes, located at 827 Landon Drive, and described as a portion of the Sun River Mesa Condominiums, Tract 5142, Section 21, T21N, R21W, Bullhead City, AZ.
