MAY WE MAKE SOME SUGGESTIONS?

DEAR PROPERTY OWNER:

Due to the strong winds in Bullhead City, we would prefer that you cut and trim all weeds and grass growth at ground level, rather than plough them under.

This would allow some ground cover to remain, which in turn helps with dust control.

Additionally, based on past history, regardless of the method used, vegetation usually reappears within an average of six months from the time the lot is cleared.

It is okay to leave certain types of natural vegetation, such as:

Assorted Cacti, Creosote, Ice Plant Mesquite.

Most times this vegetation just needs to be trimmed.

Again, we are trying to minimize erosion and the amount of blowing dust.

All weeds and grass growth needs to be removed and lawfully disposed of by disposing at one of the Mohave County landfills.
