PUBLIC HEARING – ZONING MAP CHANGE Z24-002/SUBDIVISION S23-003 –

Request for approval of a zoning map change from R2MF-PAD (Residential: Multiple-Family District – Planned Area Development) to R1L-PAD (Residential: Single-Family Limited – Planned Area Development) and approval of the preliminary plat for a project known as Desert Rose and described as Parcel G of Chaparral Terrace Estates, Tract 4020, Bullhead City, AZ.

<u>PUBLIC HEARING</u> – **ZONING MAP CHANGE Z24-003** – Request for approval of a zoning map change from C2 (General Commercial) to R2MF (Residential: Multiple-Family) for a 1.926 acre parcel of land located at 490 Riverview Drive and described as a portion of Government Lot 1, Section 25, T20N, R23W, Bullhead City, AZ.

<u>PUBLIC HEARING</u> – CONCEPTUAL PLAN P24-001 – Request for approval of the conceptual plan for a project known as "Emerald Bay" which is generally located at the southwestern end of the Bullhead Parkway and west of Highway 95, and described as portions of Sections 2 & 3, T19N, R22W and Section 32, T20N, R22W, Bullhead City, AZ.

PUBLIC HEARING - CODE AMENDMENT - ARCHITECTURAL STANDARDS -
