Discussion and possible action to approve the construction contract with Premier Backhoe for the replacement of a portion of a 24-inch sewer main located on Merrill Avenue in the amount of \$271,986.07 and authorize the City Manager or his designee to execute the agreement and issue resultant payments. Utilities Director Clark said this item is a continuation of a project that was completed last year. He said there was an emergency situation where the sewer main on Highway 95 collapsed. He said they had to get the sewage cleaned up and the line replaced. He said the rest of the line that is going to be replaced under this item is partially collapsed.

Vice Mayor Alfonzo said this project did go out to bid and said Premier Backhoe was the lowest bidder by \$61,573.00.

Mayor D'Amico asked if anyone from the public wanted to speak on this item. No one spoke.
